RESOLUTION NO. 05-19

A RESOLUTION AUTHORIZING THE RATE OF PROPERTY TAX FOR THE TOWN OF AVOCA, ARKANSAS FOR THE YEAR 2019 TO BE COLLECTED IN 2020

WHERAS, Arkansas Code Annotated §26-25-102 provides that a city/town may levy a tax on the real and personal property located within the town for general purposes, in any one year, pursuant to the provisions of the Arkansas Constitution; and

WHEREAS, the Arkansas Code Annotated §26-73-202 requires the City Council of any municipal corporations to make out and certify to the county clerk the rate of taxation levied by the city/town on all the real and personal property within the city or town; and

WHEREAS, the Town Council of Avoca has determined that it is in the best interests of the Town of Avoca, Arkansas and its citizens to levy the rate of taxation on the real and personal property located within said town as set forth herein, and to certify the same to the County Clerk, and authorize the Quorum Court of Benton County to levy said tax for the year 2019, to be collected in 2020.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Avoca, Arkansas, as follows:

- 1. That the property tax rate for Avoca's <u>General</u> purposes on the real and personal property situated within the town to be collected in the year 2020 shall be fixed and levied at the rate of **5.0 mills** on each dollar of assessed value of real and personal property.
- 2. The rate of taxation levied herein on the real and personal property within Avoca shall, by this Resolution, be certified to the Benton County Clerk to be placed upon the tax books and collected in the same manner that the state and county taxes are collected.
- 3. The Quorum Court of Benton County is hereby authorized to levy the said tax as set forth herein for real and personal property located within Avoca, for the year 2019, at its regular meeting in November according to law.
