  - a. None; February meeting was canceled due to lack of agenda.
- 2. Board of Zoning Adjustments- Chairmen Alvarenga
  - a. None
- 3. Streets Ald. King
  - a. Snow Removal; Ald. Alvarenga brought to Council's attention, he had received complaints concerning the snow removal on Hobbs Road and a few other streets in town.
  - b. Truck Route; Ald. Hansen states Old Wire Road is a truck route and asked that the trees be trimmed back and maintained better due to the overhanging trees damaging trucks.
  - c. Safety Lights; Ald. Alvarenga asks that the town purchase more caution lights for the town truck. Council agreed. Ald. Alvarenga will look into prices.
- 4. Park Ald. Hansen
  - a. Trail Lights: No updates
  - b. Bull Pen: Ald. Alvarenga would like to see the trees trimmed around the fence and the bullpen cleaned and maintained better. Rec/Tres. Barnes will contact APAC to get some gravel delivered to help with the muddy areas around the bullpen.
- c. Truck Parking; Ald. Hansen brought to the council's attention, there are some semi-trucks parking in the Steam Whistle parking lot. Council decided, truckers can park there overnight (no long term parking) if they live in the town limits/planning area of Avoca, they will need to contact Town Hall prior to parking.
- 5. Personnel Ald. Oakes
  - a. Emergency Hours: Ald. Alvarenga asked that the town's street crew divide shifts if needed due to inclement weather. Council agreed.

### **Old Business**

1. Town Hall Door Buzzer: Rec/Tres. informed council her and the Mayor will be meeting with the ADT representative tomorrow concerning having a security buzzer placed on the front door.

### **New Business**

- 1. Tractor Tires; Ald. Alvarenga recommends we replace the tractor tires sooner rather than later due to the shape they are in.
- Trash cans: Rec/Tres. Barnes and Mayor Whitehorn have been trying to get trash cans delivered to Residents who do not have one. Ald. King states he has also tried contacting Waste Management regarding this issue.
- 3. Heater in shop: Ald. Alvarenga recommends placing a heater in the shop. Different options were discussed.
