Assistant Fire Chief Ervin states Avoca Fire & Rescue ran a total of 53 calls for August.

On August 18th Avoca was dispatched to a Structure fire on Cemetery Road, Crews were able to make a quick stop and limit the damage to the home.

Our turn out time for the month of August from time of tone to first person responding was 1 min 27 secs, The first Avoca fire apparatus was responding 1 min and 46 sec. Avoca's busiest day was August 13,2022 with 6 total calls.

a. 411 Sheppard Road; Leonard & Mindi Stewart: Tim DePue states he has contacted Mr. Stewart concerning a complaint that was filed concerning the junk on the property, re: unsightly and unsanitary conditions. Mr. Stewart was in attendance (see public forum).

6. Park - Ald. Hansen

a. Food Truck Court; Rec/Tres. Barnes states the food truck area is close to completion and should be open within the next two weeks. Paul Brush was hired to build safety bars that will be placed around the waste water inlet/outlet to keep them from being run over. Ald. Hansen made a motion to amend the food court budget to \$25,000.00 (twenty-five thousand dollars and zero cents). Seconded by Ald. King. Discussion: none. All approved, motion carried.

b. Monument; Due to illness, the person who was going to rebuild the monument in front of the Avoca Town Hall, is now unable to work. Mayor Whitehorn appointed Ald. King to over see this project to completion.

7. Grants - Ald. Rairdon

- a. Rural Community and Rural Services Block Grant for park equipment. Rec/Tres. Barnes states she got a call stating the town is eligible for this grant and was told they will let us know if we have been approved for the grant.

Council Member Hansen - asked that the park budget for 2023 remain the same and to price a new mini x or backhoe for the 2023 budget. She offered to paint the little food pantry up at the Whistle Stop Park, to make it more colorful and inviting.

Council Member King - stated he would like the town to concentrate on the roads and how we are going to fund the cost of repairing them with the two new subdivisions going in and the greater amount of traffic. Ald. Hansen asked that Impact Fees be placed on October agenda.

Leonard Stewart addressed the council concerning the unsightly and unsanitary complaint. He states he lost the lease on the place he was renting and had to move all the cars out to his property. He has since had an auction, and has gotten a new lease on a place in Lowell. Mr. Foerster states he still has junk and other items that look bad, and part of Mr. Stewarts stuff and fence was on his property. After some discussion, it was determined the issue was more of a civil case.

Betty Wasserman asked that the stage coach be on any logos the town used due to the history of the town.
