Financials:

- 1. March Report: Financial report presented by Rec/Tres. Barnes. Ald. Aikins made a motion to accept the March 2025 financials as presented. Seconded by Ald. Alvarenga. Discussion: was held concerning the need to constantly purchase stop signs. Due to safety reasons, it was decided against placing boulders around the stop signs in town, to deter people from running them over. Roll call: Ald. Alvarenga; yes, Ald. Rairdon; yes, Ald. King; yes, Ald. Aikins; yes, and Ald. Rollins; no. Motion carried.
- 2. BC Resolution R-2025-15; Refer to Voters-Reallocation of County Wide One Cent Sales Tax for New Jail: Mayor Whitehorn updated the town council of the meeting he attended concerning this issue. He wants the council members to know that if the residents of Benton County pass this issue at the next election, the Town of Avoca will lose around twenty thousand dollars (\$20,000.00) a year, and for a small town like ours, that will be a big hit for us.

1. Avoca Fire Department - Avoca Fire Chief

a. Ran a total of 74 calls for March and 166 for the year

b. Fire Station was manned for 22 days in March

Ald. Alvarenga wanted to discuss Mercy and Air-E-Vac Life Team helicopters landing in the town park. He was told by the Avoca Fire Chief Oldebeken that the town did not want them landing in the park. Mayor Whitehorn, Rec/Tres. Barnes and Chris Rogers, all told him that information was incorrect, and the town employees went down to the Avoca Fire House to find out if any landed in the park recently, due to the soccer goals being pushed over. They were checking due to vandalism being carried out in the park and the town employees wanted to anchor down the goal posts far enough apart, so it was safe for the helicopters to land. It was decided, town attorney McClure would write up a shared use agreement with both Mercy and Air-E-Vac Life Team stating they had permission and were more than welcome to land on any and all town property any time they needed.

5. Park - Ald. Rairdon

- a. Pickleball Court: Mayor states the paint and nets have been purchased, waiting on the weather to continue this project.
- b. Wooden Fence Repair/Replace: Mayor Whitehorn states he met with four different companies about the fence, only received two estimates back. Mills Tree Service recommended removing the 200 feet of wooden fences and placing them with bright yellow Forsythias at the cost of one thousand, one hundred and twenty-five dollars (\$1,125.00). M& W Outdoor Services gave an estimate of four thousand, eight hundred, four dollars and thirty-one cents (\$4,804.31) to remove old fence and replace with new wooden fence (use what old fence is useable). The council talked different options and would like estimates on a "Green Coated Chain Link Fence". Recorder/Treasurer will put it on social media and the town sign.

Ald. Rollins states most grants sights are closed due to the government, she will continue to look for non-matching grants that will help with the following issues that the town needs:

 - i. Pursley No Update
- b. Business Licenses
 - i. Out of town contractors Mayor asked Council to reconsider charging out of town contractors a business license to work in the town. Ald. Aikins states Rogers is the only town that checks this, and if you have a business license in another town, they do not have you get another license through Rogers. Ald. Rollins doesn't believe this would be fair to out of town businesses that do come in and get a license, because there will be some out of town businesses that will not come and get a license. Ald. Aikins and Ald. Rollins both stated they are opposed to adding additional fees to contractors. Recorder/Treasurer Barnes explained to the council members they need to understand if the reallocation of the one cent sales tax passes for the new jail, and if the town loses twenty thousand dollars (\$20,000.00) a year, this small town is going to be in a lot of trouble. If they do not want to add additional fees to out of town contractors, the council needs to find other ways to bring money into the town. Mayor Whitehorn agreed. Ald. Alvarenga stated he needs to pay business licenses in all towns he does business in (Per Ald. Aikens - amended to: for a business license in Rogers). Mayor Whitehorn asked to table this issue until next month. A motion was made by Ald. Alvarenga to table this issue until next month. Seconded by Ald. King. Discussion: None. Roll call: Ald. Rairdon: no, Ald. King: yes, Ald. Aikins: no, Ald. Rollins: no, Ald. Alvarenga: yes. Motion failed. A motion was made by Ald. Rollins to end the issue of Business Licenses for out of town contractors. Seconded by Ald. Aikins. Discussion: None. Roll call; Ald. King: no, Ald. Aikins; yes, Ald. Rollins; yes, Ald. Alvarenga; no, and Ald. Rairdon: ves. Motion passed.

- a. Resolution 05-25: Dispose of Excess Personal Property of the Town of Avoca Attorney McClure read Resolution 05-25 on its 1st and final reading by title only. A motion was made by Ald. Rollins to accept Resolution 05-25 on its 1st and final reading by title only. Seconded by Ald. King. Discussion: was held on what items and how the items will be disposed of. Roll Call: Ald. Aikins: yes, Ald. Rollins: yes, Ald. Alvarenga: yes, Ald. Rairdon: yes, and Ald. King: yes. All approved. Motion carried.
- b. Ordinance 131: New Fee Schedule Attorney McClure read Ordinance 131 in its entirety. A motion was made by Ald. Alvarenga and seconded by Ald. Aikins to approve Ordinance 131 on its 1st reading in its entirety, and its 2nd & 3rd reading by title only. Ald, Aikins asked to see the Ordinance; Attorney McClure apologized for getting the Ordinance to the council late due to a staff issue at his office. Discussion: Ald. Aikins questioned the wording of the Benton County fee structure. Roll call: Ald. Rollins: yes, Alvarenga: yes, Ald. Rairden: yes, Ald. King: yes, and Ald. Aikins: yes. All approved motion passed. Attorney McClure read Ordinance 131 on its 2nd reading by title only. A motion was made by Ald. King to approve Ordinance 131on its 2nd reading by title only. Seconded by Ald. Rairdon, Discussion: Ald. Aikins wanted to read Ordinance 131 and the minutes of the committee meeting before voting. Ald. Aikins wanted to adopt all of Benton County's Fee schedule. He was informed that was not what the committee decided. (Per Ald. Aikens - amended to: Recorder/Treasurer Barnes claimed that was not what the committee decided). Attorney McClure stated the motion was to accept the ordinance on the 2nd reading, if the council decides not to approve it on the 2nd or 3rd reading, the ordinance can come back at a later date with different numbers, if the council decides that is what they want to do or if they want to approve as is. Roll call: Ald. Alvarenga: yes, Ald. Rairdon: no, Ald. King: yes, Ald. Aikins: no, and Ald. Rollins: no. Motion failed. A new Resolution will need to be written per town Attorney McClure. Ald. Aikins stated he didn't agree with the ordinance and stated he should not have approved of the March minutes that he approved earlier in the night. Ald. Alvarenga, explained to Ald. Aikens the minutes from the committee meeting will not match exactly what the council minutes say. Ald. Aikins stated he could not comprehend the Ordinance at this time. The attorney stated the Ordinance is now dead, and if a new ordinance wants to be brought before the council it can be done at a later date.
